 - a. Welcome
 - i. Senate Sponsor Jamaal Bailey and his chief of staff
 - ii. Assembly Sponsor Michaelle Solages
 - b. The AT Licensure Bill passed both houses!
 - i. Comment letter written by GA and sent to Governor requesting Chapter Amendment to address Neuro language limitations (waiting on signature)
 - ii. There are some chapter amendments
 - iii. What licensure means:
 - Enactment (in 2 years) doesn't begin until 2 years after being signed
 - Grandparenting means all currently NYSED certified members will automatically become licensed
 - Standard written protocol written in collaboration between and signed by AT & supervision physician(s)
 - Physician limits (can only supervise 4 ATs) with exceptions
 - Referral back to the physician required after a certain amount of time (4 days & 2 weeks).
 - Continued competence requires mandatory continued education
 - Limited Permit ATs newly BOC certified or new to the state can apply for a limited permit which will allow them to work in NYS as an AT under supervision until they receive their license
 - -Traveling ATs into NYS AT's traveling into NYS will not be able to practice. Bill will be introduced each year (like ironman/NYC marathon) as an amendment
 - c. NYS Healthcare Worker Bonus Program
 - i. Those in hospital settings were able to receive it. Those in schools were not. Karin and Assemblymember Solages tried to advocate for it, but it didn't get anywhere.
 - d. Lobby Day
 - i. Organized by GA committee & Karin and staff participation by over 10 ATs and met with over 20 legislators very well received (April 25)

- e. Concussion Outreach Prevention & Education (COPE)
 - i. \$175,000 awarded to NYSATA & BIANYS joint project (Sponsor Senator Hoylman-Sigal)
 - ii. Allow us to hire someone to coordinate the creation of educational programs in NYS.
- f. Concussion Management & Awareness Act
 - i. Working with BIANYS to update the laws
- g. A4944A CPR/AED Bill (Assembly Member Santabarbara)
 - i. A bill for CPR/AED training in youth sport coaches. Yet to get a senate sponsor.

Decrease in membership in NYS by 167 which is 11%. D2 decrease of 537 which is 10.3%. Increase in associate members, decrease in student/certified professional.
