Governmental Affairs Report and Legislative Update Aimee Brunelle, MS, ATC and Deanna Errico, PT, DPT, ATC - Co-Chairs Karin Carreau - Carreau Consulting

The AT Licensing Bill will be enacted on December 23, 2025, two years after Governor Hochul signed it. This practice act legislation provides ATs with their new scope of practice. Are there new aspects of practice that will be different and we will need to become accustomed to? Yes. However, we also need to review the currently proposed Rules & Regulations, which the New York State Education Department (NYSED) AT Board helped to draft and which will provide the practice detail that the AT Bill does not. The license holds mandated requirements for practice, it cannot be changed without opening up the practice act again and going through the arduous process of legislating change. The Rules & Regulations however, have a short time period in which constituents can make comments and these will be taken into consideration by the Board of Regents before they adopt them (See pages 15-18). The 60-day comment period ends February 23, 2025.

NYSATA Governmental Affairs will participate in an educational campaign with NYSED to explain the differences between the bill, the rules & regs, and new licensure requirements. We are planning a Town Hall to kick this off in the coming months. Look for information to come out soon.

It is a new legislative session and the AT Traveling Bill has been introduced in the Assembly (Bill A2643) and will soon be introduced in the senate. This bill is necessary to allow ATs outside of NYS to travel with their teams into the state and provide AT services to their athletes. This is DIFFERENT than the Federal Sports Medicine Clarity Act (SCMA) that passed in 2018. The SMCA protects the traveling AT by allowing their own liability insurance to cover them out of state. The NY AT traveling bill will protect the AT so they can perform their scope of practice

in NYS during their short travel. How does it protect you? Our already overworked ATs should not have to take care of another team that travels to your institution because their AT had to stay home to avoid breaking the law.

NYSATA continues to collaborate with the Brain Injury Association of New York State (BIANYS) on the Concussion Outreach Prevention & Education (COPE) grant. This past fall we held multiple events on concussion awareness (thank you to ATs: Laura Goodwell-Velez, Anthony Jones, Jillian Perrault, , Lauren Stephenson, Craig Olejniczak, Phil Steckley, Jarrett Rhoads, and Allyson Lee Barton for their presentations and to those ATs who assisted in hosting - Jon Jalon, Ali Ferrara, Kelsey Shonk,). We also had ATs promote AT and COPE at professional conferences (thank you to Laura Goodwell-Velez, Aimee Brunelle, Caroline Peyron, Lauren Stephenson, Amy Grover, Allie Balotin, Kevin Joyce).

We are working to secure another legislative grant this year to continue the COPE project.

Another reminder that BIANYS has secured free CEUs for athletic trainers by taking their **Concussion Education Modules**. Two free, online learning opportunities presented by renowned concussion expert and Medical Director of the University at Buffalo Concussion Management Clinic Dr. John Leddy. These are recorded, on-demand modules, in which Dr. Leddy provides the latest evidence-based information and strategies for assessing and managing concussion patients. 


NYC closed out 2024 with a holiday gAThering!

What does the Treasurer position entail?

- Serve as a member of the Executive Council.

- Handle the receipt and disbursement of all monies to and from the NYSATA and maintain a file of proper documentation to account for each transaction.
- Keep and maintain a permanent and accurate record of all receipts and disbursements of the NYSATA.
- Annually submit official books for audit to the Audit Committee or upon request of the Executive Council.
- Submit a financial report to the membership at all business meetings.
- Commit the NYSATA to no financial obligation in excess of its available financial resources.
- Cooperate with the President in matters of finance dealing with the annual meeting and Conference Committee Chair in matters of the annual conference.
- Term of Office shall be two (2) years and may be re-elected.
- The Term of Office shall be followed by a one (1) year Past-Treasurer position to transition the responsibilities to a newly elected treasurer.

What does the Regional Representative position entail?

- Serve as members of the Executive Council.
- Act as a liaison between regional members and the Executive Council.
- Solicit information from regional membership for the NYSATA Newsletter.
- Implement the policies and actions of the Executive Council within their regions.
- Serve on the Membership and Nominating Committee along with the NYSATA Secretary.
- Annually attend 1 meeting of the Executive Council.
- Term of Office shall be two (2) years. The Regional Representative will be voted in by regional membership. May be re-appointed with Executive Council approval.
