

NYSATA Membership Meeting at EATA- January 6, 2024 at 5pm-6pm In Person/Virtual

- 4. Thank you to all volunteers for NYSATA.
- 5. Reports
 - a. Secretary Decrease in overall membership in NYS of 69 total members, or -4.5%. Overall D2 membership down 245 members, or -4.7%. Increase in certified retired but decrease in certified student and certified professional. From NATA we are expanding members to stay stead. Reach out to your colleges who aren't members and explain to them the importance of membership. We had a grant from NATA of \$35,000 that we no longer have, so that is why membership is so important to us.
 - b. Treasurer Ran a deficit in 2023 following a deficit in 2022.
 - i. Contributing factors of declining membership and lack of substantial sources of secondary income. Following the NYSATA Conference, left with a small amount of capital to cover expenses for the rest of 2023.
 - ii. Actions Taken. Suspended services with Buzz Media on Oct 23, replaced with Stephen Foster resulting in a savings of ~\$12,000 per year. Sold a small amount of assets in INvestment Account to cover remaining debts for 2023. Established plan for restoring assets to Investment Account. This will be reviewed by the EC quarterly with the goal of restoring assets by end of year. Sale of Assets to not exceed \$20,000. Will use this as an opportunity to restructure our various investments and increase ROI.
 - iii. Financial Plan. Limit Expenses for 2024 by cutting down Social Media/PR costs. Lower reimbursement allotments for EC/LC. Continue to review expenses for additional opportunities for savings. Improve Various Revenue Streams for 2024 and Beyond. Establish formal Sponsorship packages in line with other State Organizations. Organize Fundraising events and programs throughout the year. Promote NYSATA Conference (June 2024) and look towards boosting attendance both in and out of state. Goal is to limit losses to less than \$5,000 for 2024.
 - iv. We are currently looking for a fundraiser chairperson. If you or you know someone who is interested. Please let one of us know.

- a. Governor Hochul signed legislation A.219-A/S.942 [12/22/23]
- b. Future Bills for ATs in NYS to work on passing in 2024:
 - i. Chapter Amendment neuro language. Was already agreed to, so we have no opposition.
 - ii. CPR Bill Requires CPR and AED for youth sports in NY. The assemblymen had this idea and came to us with the Bill. We are being looked at as the experts.
 - iii. Traveling AT Bill Necessary for ATs traveling to NY with teams. This is something passed with physicians, so we will have to do this for the AT's as well. This is an additional amendment that will need to happen.
 - iv. This doesn't go into effect until 12/22/25 when we will actually be licensed professionals. As long as you have maintained your NYS Dept Of Education Credentials, you will be grandparented in.
